An Invitation to the Doctorate in Leadership

The question is not “what is leadership?” but “what is good leadership?” Good leadership, like critical thinking, crosses all boundaries and applies to all work environments. Current events in society demonstrate the need for effective leadership. Significant writers and leaders agree that good leadership requires good character. HSU’s inherent Christian foundation and values provides the perfect base for fostering exemplary character essential for leadership.

Graduate education plays a vital role in the future of the United States, the premier location for graduate education. In order to be globally competitive, graduate education must continue to be a priority. The increased complexity of the U.S. workplace require advanced degrees for many jobs. . Just as baccalaureate degrees overtook high school diplomas as the preferred preparatory training in the 1980s, master’s degrees have overtaken baccalaureate degrees as the accepted degree for many careers. Similarly, doctoral degrees may become the expectation for many career paths.

U.S. News and World Report lists higher education administration among the Best Careers of 2011 with a strong job market for university administrative positions, requiring a master’s or doctoral degree. Growth in the community college sector is projected to be even stronger. The U.S. Bureau of Labor Statistic projects a rapid employment growth rate of 8 percent in the field of higher education administration for 2008-2018. In May 2008, they reported that postsecondary school administrators earned a median income of \$80,670. The middle 50 percent earned between \$58,940 and \$113,860. While salaries vary based on location and enrollment, administrators during 2008-2009 earned up to \$158,000.

Graduate education at HSU prepares individuals to be critical thinkers, problem solvers, and well-rounded citizens. The Doctorate in Leadership (Ed.D) offers academically rigorous curricula and practical experiences that creates leaders in the organizations and communities of tomorrow.

Purpose Statement

Doctorate in Leadership

The Doctorate of Education in Leadership (Ed.D.) develops enlightened, ethical leaders through academic and practical experiences. Through study in a faith-based environment, graduates will embody skills, knowledge, and dispositions to bridge theories with research-based practices to become visionary leaders.

This 57-hour program follows a cohort model over four-years. The cross-disciplinary nature of the program accepts students from any fully accredited master's degree. Students complete six hours of coursework each fall, spring, and summer, allowing for continuation of employment. Students will read the Great Books of leadership to support a breadth and depth of knowledge in the field. At the end of the program, students will take qualifying exams that require synthesis of knowledge gained through these readings, leadership coursework, and individual research. The culminating experience for the doctoral degree involves the completion of a dissertation related to the student's interest in a particular aspect of leadership and supervised by a professor.

The Doctorate of Leadership program contains four distinct practices that support effective pedagogy and doctoral study, enmeshing the on-campus environment with various delivery methods:

- Considers the *cross-disciplinary nature of leadership*
 - Offers 18-hour concentrations in three areas: Higher Education Leadership, Education Leadership in Superintendentcy, and Educational Leadership in Health Science Professions
- Bridges the academy to the community
 - Provides clear connections between academic study and real-world applications
- Offers a hybrid, low-residence model
 - Meets on campus three weekends a semester, with additional faculty/student interactions through online environments
 - Supports collegial support, enhanced camaraderie, and professional networking through a cohort model with face-to-face contact
- Includes *three brief summer residencies*
 - Studies leadership in authentic settings in Austin, Texas; Washington, D.C.; and Austria/Germany for approximately one week each summer

Admission Requirements

The following is required of applicants for the Doctorate in Leadership program: (see detailed directions listed below)

- A minimum cumulative grade point average of 3.5 on a 4.0 scale at completion of a master's program
- A competitive score on the GRE (Graduate Record Examination) taken during the last ten years. Upon approval, scores from the GMAT (Graduate Management Admission Test), MAT (Miller Analogies Test), or other comparable nationally recognized aptitude tests may be substituted.
- Additional scores required for students whose native language is other than English: score of 250 on the computer version of TOEFL, score of 5 on the TWE, score of 50 on the TSE
- Recommendations forms from three persons qualified to assess your abilities and potential for the program.
- Resume or curriculum vita
- A 500-600 word personal statement
- Copy of Valid Texas Teacher's and Principal's Certificate (superintendent only)
- All required documents listed in the Admission Procedures and Checklist

Admission Procedure and Checklist

All materials must be received in the HSU Graduate Studies Office by April 11, 1:00 p.m.

Qualified applicants will not be considered for admission until their file is complete.

Forms submitted online:

- \$50 application fee (\$150 for international students) through Cashnet <https://commerce.cashnet.com/cashnetc/selfserve/BrowseCatalog.aspx>. The application fee is waived for graduates of Hardin-Simmons.

Forms sent directly to Graduate Studies Office:

- Official transcripts from each institution you attended
- Official copies of GRE scores. (HSU GRE Code: 6268) If needed, request approval of other comparable nationally recognized aptitude tests through the Program Director
- Official scores required for students whose native language is other than English. They must earn a score of 250 on the computer version of the TOEFL (Test of English as a Foreign Language), a score of 5 on the TWE (Test of Written English), and a score of 50 on the TSE (Test of Spoken English) and meet the required scores.

Forms submitted online as supplementary materials:

- A resume or curriculum vita documenting educational background, professional experience, employment history, certifications, professional development, honors/achievements, and community service
- Signed Ethics Statement
- A 500-600 word personal statement following the guidelines described in admission materials
- Completed form that includes the list of Personal References
- The Letter of Employer Support form, completed and signed by the current employer
- Copy of Valid Texas Teacher's and Principal's Certificate (superintendent only)
- Release for conducting a background check

Forms submitted directly from references:

- Recommendation forms from three persons who are qualified to assess your professional abilities, academic potential, and personal character. Ask each person to submit the completed form directly to HSU Graduate Studies via email, fax, or mail.

Following a review of the application, applicants may be contacted to schedule a personal interview.

3. A self-analysis of the applicant's potential for doctoral level critical thinking and research
4. Evidence of leadership achievement and potential
