
Dear Camper,

WHAT SHOULD I BRING?

Necessary forms for registration (You will not be allowed to participate without them)

1. Student Conduct Agreement Form
2. Dorm Key Agreement Form
3. Medical Treatment Consent Form
4. Release and Indemnification Agreement
5. Photo Release Form

Approximately \$25 cash to purchase All-State Music Packet at registration in the Music Building. You may purchase this music ahead of time if you wish. We cannot accept checks or credit cards for this purchase.

Modest clothing and shoes suitable for hot outdoor weather, lots of walking, and air-conditioned classrooms. T-shirts and shorts must reflect good taste.

Additional attire for talent show and social activities.

Extra cash for incidental expenses. Many campers enjoy exercising the option to choose supplemental snacks at free times during camp.

Bed linens. Sheets need to fit a twin-sized bed. Don't forget a pillow, comforter, and any other bed-making items needed for a comfortable stay in the dorm.

Towels, washcloths, soap and shampoo, toiletries, sunscreen, shower slippers, hangers, and alarm clock.

Swimwear and towels. Use conservative taste when selecting swimwear. Campers wearing inappropriate suits will be asked to change into clothing and not permitted to swim.

Umbrella.

Talent Show items - optional. Costumes, accompaniment CDs, sheet music, etc.

Things to do in "down time" at dorm: board games, cards, guitar, book, etc.

All-weather jacket or sweatshirt. Classrooms can get quite cool in the summer.

Backpack to carry music, pencils, sweatshirt, water, etc.

Attire for final concert: Men: black pants, white shirt, black shoes and socks, black bow tie. Ladies: black skirt - length must be below knee or black dress pants, white blouse, black or natural pantyhose, black shoes (no flip-flops).

WHILE

ON CAMPUS

Supervision

Our experienced counselors are comprised of HSU undergraduate music majors, alumnus, and members of HSU music ensembles. We maintain a counselor-to-camper ratio of at least 1:10 and endeavor to have an equal distribution of voice types (soprano, alto, tenor, and bass) between counselors and campers. Campers are supervised at all times by counselors, staff, or faculty, checking in at all strategic moves throughout the day as well as at breakfast, before dinner, and evening meetings with counselors. Throughout the day, attendance is taken at the beginning of each class.

Housing

Campers are housed in one of our residence halls located on the HSU campus, with rooms accommodating two people per room. Counselor's rooms are on the same floor with their assigned campers.

Although requests cannot be guaranteed, residential campers may indicate a preferred roommate on the registration form. Campers who both specifically request one another will automatically be assigned as roommates. In the event several campers request the same person, we will do our best to accommodate the camper's wishes. All further roommate requests or changes must be in writing. If no roommate preference is indicated, an effort will be made to match students of the same age and voice part. Campers may not switch roommates upon arrival at or during camp. Visitation between campers of the same gender housed in different floors is allowed at discretion of the camper's assigned counselors.

Meals

Three meals are served daily Monday through Wednesday, with dinner on Sunday and breakfast and lunch on Thursday. Main entrees will vary from day to day. Campers and counselors eat together and are asked to properly clean their area once everyone in their group has eaten. Vegetarian selections are available.

It is common for residential campers to pool their resources and order pizza following evening activities. Vending machines for soft drinks, candy and other snacks are available in the dorm. Campers may bring additional snacks. Concessions will be for sale during camp by the various music organizations.

Campers are advised to keep their rooms locked and to leave non-essential and valuable personal items at home. Never leave items of value unattended. The camp cannot be responsible for loss of camper's personal money or other assets.

RULES

FOR CAMPUS AND DORMS

Campers are expected to acquaint themselves with the rules, procedures, and standards of conduct established by the HSU Choir Camp. A camper who does not fulfill the responsibilities set out by such rules, procedures, and standards of conduct may be subject to disciplinary action, including dismissal from camp.

- Campers are required to wear their nametag in clear view at all times.
- Clothing must be appropriate. Same rules as public schools.
- Every activity for camp has a designated parameter (e.g. the music building, the residence hall, and the cafeteria). For security reasons, campers are to remain within the designated parameter, and when traveling across campus, will need to do so with a HSU Choir Camp staff person. Campers should not have any need for internet use; therefore campers are discouraged from internet use during camp events. HSU will not be held responsible for actions of a camper who is in violation of these rules.
- For safety reasons, any outside visitors will need to check in with the camp director.
- Campers are expected to eat all contracted meals within the camp parameters. No resident camper may leave campus or have meals delivered to them by friends or family. Special concerns should be written.
- No violation of any local, state, or federal law is permitted (includes alcoholic beverages for a minor and smoking).
- Possession of illegal drugs, drug paraphernalia, fireworks, chemicals, gasoline, or other explosives, firearms, illegal knives, clubs, or prohibited weapons is reason for immediate removal from the camp without refund. Prescription and over-the-counter medication is only allowed if listed on the medical form that is enclosed in this packet.
- Absolutely no form of sexual misconduct, harassment, violence, threats of violence, or other acts of communications intended to intimidate, harass, or annoy will be tolerated.
- Campers may not be in rooms of campers or staff of the opposite sex.
- Be respectful of others in the dorm. There are other camps and HSU students staying in the dorm during the summer. No running or loud noise of any kind is permitted in the hallways. Rooms must remain quiet at the time of curfew, which can be found on your schedule. No pets allowed.
- Do not remove or harm the furniture or property in the dorms. Payment of any damage to the dorm facility is the camper's responsibility.
- Dorm room keys are issued for personal use and are not transferable. Campers should always lock the unit doors, as they are responsible for any lost or stolen items. Lost keys must be reported immediately to a counselor. There is a \$10 charge for lost keys.
- Do not tamper with any fire equipment, including extinguishers, exit signs, smoke detectors, sprinklers, fire alarms, and fire doors. There is to be no use of fire in the dorm, including burning candles and incense.
- Should there be any maintenance-related problem evident in your dorm room, particularly safety-related issues or flowing water, you should report it immediately to a camp counselor.
- Removing window screens is prohibited. Therefore, the window is not to be used as a point of entry or exit, and items may not be thrown from window.

WHAT IS GOING ON?

How to Get to HSU Choir Camp

From east or west on I-20, take the Pine Street exit (exit 286A). Go south. Pine Street will split but stay to your right until you see the HSU campus. Turn right into the Pine Street HSU entrance on Linebery Blvd. (just past the building with the gold dome). Take a right at the clock tower. Hemphill Music building will be on your left.

At registration, dorm room assignments will be given. Our dorms are housed on the HSU campus and campers may choose to drive to the dorm to unload their belongings. Thereafter, we ask that campers who are driving their own cars leave their cars at the dorm location (yes, that means walking back to the music building!) and walk with their assigned counselors for each day's activities.

What to do on the First Day

Report to the music building between 2:00 and 3:00 p.m. At this time you will complete registration, purchase music for the week, and receive dorm assignments. If you are staying in a dorm, you will want to arrive closer to the 2:00 p.m. check-in time in order to take care of purchasing music and unloading your belongings at the form prior to the 3:00 p.m. opening ceremonies. If you are a commuting camper, you may arrive anytime in the afternoon check-in time.

Opening ceremonies are at 3:00. Parents are invited (but not required) to attend this short ceremony that kicks off camp. To see what else the week holds in store, a tentative schedule for the remaining week is included in this packet.

What to do on the Last Day

The week of camp concludes with a concert at 3:00 p.m. in the Woodward-Dellis Recital Hall located in the School of Music Complex (the building where you registered for camp). Parents, family, and friends are invited and encouraged to attend this concert. At the conclusion of the concert, campers will be released from the Hardin-Simmons Camp supervision. At that time, campers who are housed in the residence halls will need to return to the room to collect their belongings. Counselors will advise the campers about this process on Thursday night. Failure to return a dorm key will result in a \$10 replacement fee charged to the camper. Any belongings left behind will be donated to charity.

Insurance and Health Care

Campers should keep health insurance documentation with them during their time at camp. If not a true emergency, there should be sufficient time for parents to be contacted. Parental notification of minor injuries and illnesses is left to the discretion of the camper. Please discuss with your child your expectations regarding communication of such information. HSU Choir Camp cannot be responsible for or held liable for the administration of medication to campers. The camper must be able to self-administer his/her own medication.
